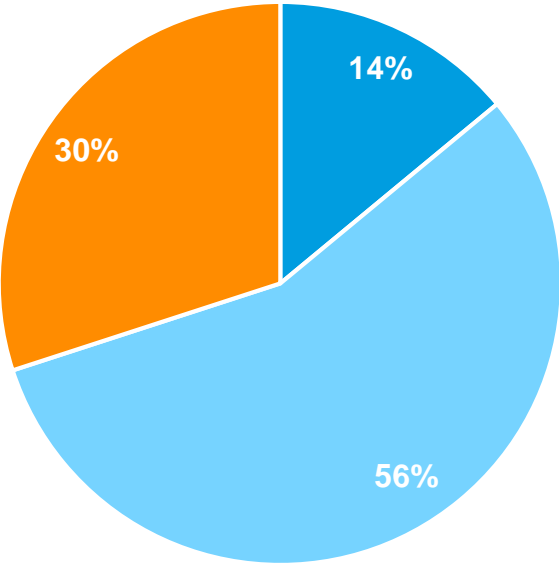

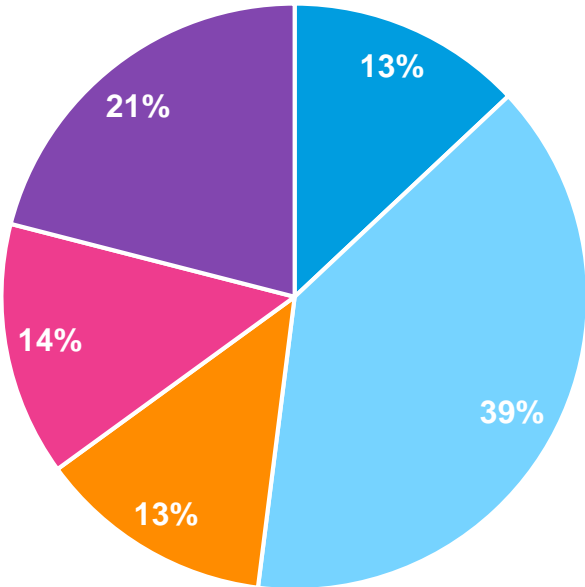
Enrollment Results

MDLive

- Available for both BCBS and HCH members
- Provides urgent care for allergies, cold/flu, cough, ear pain, rash, pink eye, UTI, sinus infections, sore throat, etc.
- Also provides behavioral health for things like anxiety, depression, life changes, grief, parenting support, relationship issues, stress management, etc.
- \$0 for members on the High and Low plans
- Covered 100% after deductible for members on the HD plans
 - Can use HSA funds to pay costs until the deductible is met
 - General medical visit is \$45
 - Behavioral health is \$80-\$250 depending on the type of provider selected and whether it's an initial or follow up visit
